**Message from the President** 

#### **Dear Fellow Rotarians**

At last we see some light in the tunnel after the lockdown due to Covid 19. Life is gradually coming back to some kind of normality in Cyprus. We acknowledge and congratulate the efforts of the medical front-liners, the team of expert advisors to the Government and of course the Government for implementing their recommendations and the people of Cyprus for adhering to the directives issued by the Minister of Health.

Regrettably the whole of Europe and the whole world are suffering from the pandemic and some countries important to our economy and particularly our tourism inflows such as the UK and others, have not managed the virus outbreak so well, hence the delay in the recovery of our economy.

During the lockdown our club continued its activities and as mentioned in our last bulletin our Member Takis Klerides Chairman of the Cyprus Economy and Competitiveness Council gave us a talk via ZOOM on the 5th of May 2020. This was the first attempt by our club to have an event via the internet and it proved to be a real success with more than 60 Rotarians from all over Cyprus attending.

The success of this event gave us the confidence to hold another event that was promoted within the Nicosia based Rotary Clubs on the 26th of May again by another one of our members, Dr. George Theocharides, our Community Director. This event was also well attended.

Both events are reported separately in this bulletin.

I am happy to report that our Global Grant project is progressing nicely, and we expect to deliver early in the coming Rotarian Year. Our cooperation with Nicosia Salamis is excellent and the committee is working well to achieve the project's authorization and delivery.

On the 26th May we held a club assembly. Unfortunately, the club assembly was not well supported and even some of our members who indicated their participation did not turn up. The decisions taken as well as the Board for the coming Rotarian year are reported elsewhere in this bulletin.

Every effort will be made to have a physical hand-over ceremony from the current Board to the Incoming Board and we are in discussions with possible venues that meet the requirements. The Board will convene in mid - June and we shall advise you accordingly.

Our District Governor Shawkat Tadros scored a first by holding a virtual District Conference of 2452 which was well organised and interesting. Those of us who attended all the sessions were impressed throughout but especially with the inspiring speech of Her Royal Highness Princess Sumaya bint El Hassan.

## **Speech by Takis Klerides**

#### "Restarting the Cyprus Economy after the Pandemic"

Takis Klerides was introduced by the President of RC Nicosia Lefkothea Demetris Pantazis

Very briefly,

Takis graduated in England and qualified as a charter accountant. He worked as a Partner in KPMG and was appointed as Minister of Finance (1999 to 2003) by President Glafkos Klerides.

Apart from his current role as the Chairman of the Cyprus Economy and Competitiveness Council (CECC) he is also a Director in many multi-billion dollar companies.

He was the Chairman of the Cyprus Basketball Federation for 10 years (1988-1998)

He is Vice- President of the Karaiskakio Foundation

He is a member of Nicosia Lefkothea RC since 1991

He is married to Nancy and they have two children.

It is not the intention to recite the talk of our speaker however Takis enumerated and described a number of measures that the Government was planning to take including the proposals that the CECC have recommended which would support the private sector including the small to medium size companies as well as their employees. He also highlighted the need for all the stakeholders (including the political parties) to unite in order to kick start the economy based on the proposed measures which are in line with the recommendations of the European Commission. He also highlighted the adverse effects on tourism which is a big part of Cyprus' GDP.

A question and answer session followed the stimulating presentation. The discussion was very lively and lasted for a long time with the speaker responding to all the questions and opinions that were tabled by the participants.

More than 60 Rotarians participated in the event throughout Cyprus.

Many congratulatory messages were received after the event which acknowledged the initiative of our club in the Covid 19 environment and the quality of the event and of course the popularity of the speaker.

## "COVID-19: Health Vs the Economy Debate in Cyprus and Abroad

The speaker was introduced by Vasilis Polemitis.

Dr George Theocharides was born in Nicosia in 1972. He graduated from The English School, Nicosia, and then he went on to receive the degree of BEng (Hons) in Electrical Engineering & Electronics from the University of Manchester (U.M.I.S.T.), an MBA from the University of San Diego and a PhD in Finance from the University of Arizona.

Dr George Theocharides is an Associate Professor of Finance at the Cyprus International Institute of Management (CIIM) and the Director of the MSc in Financial Services Programme since September 2010. He is also a Research Fellow at the UCL Centre for Blockchain Technologies (UCL CBT) and Director at Goal Portfolios Insurance Advisors. He has an exemplary career in the finance business world and academia. He is also the Chairman of the English School Board of Management and holds various other significant posts in the academia and finance world, locally and abroad
